2016 ENERGY EFFICIENCY INCENTIVES NEW RESIDENTIAL CONSTRUCTION APPLICATION



CPS Energy offers incentives to builders and contractors for new residential construction based on a "whole home performance" concept. To receive an incentive for energy efficiency in new residential construction, the building must be at least 15% more efficient than then (IECC 2015) building code. The building codes and related efficiency incentives were adopted from recommendations provided by a diverse community stakeholder process and formalized by City of San Antonio (CoSA) ordinance.

A residential structure is defined as a single-family home, a duplex or a fourplex. Each structure (not each unit) qualifies for a single rebate. Multi-family structures with more than 4 units are considered commercial construction and addressed under the New Commercial Construction Program.

To provide flexibility to builders and developers, no specific efficiency measures are identified as being eligible for energy incentives. This rebate is based on "whole home performance" and energy efficiency must be at least 15% above code to qualify. This provides builders the flexibility to use whatever building methods they feel appropriate to meet the standards.

To qualify for the New Home Construction incentive program in 2016:

Applicant must demonstrate that the home is at least 18% better than code by

- Certificate of Occupancy dated after 12/31/12
- Applications must be received within 90 days of Certificate of CPS Energy meter set date
- By participating in the program, the homebuilder agrees that CPS Energy obtains and/or retains ownership of all
 rights to existing and future emission credits, renewable energy rights to existing and future emissions credits,
 tradable renewable certificates and/or any and all other environmental benefits associated with constructing the
 property.
- Submission of an application does not guarantee a rebate.
- Rebates are issues every fiscal quarter in the form of a check.
